TAILGATING POLICY

The University of Northern Colorado tailgating policy is intended to provide everyone with an enjoyable and safe environment while attending UNC BEARS football games. The Department of Athletics in conjunction with the UNC Police Department hope you will enjoy yourself, while respecting the rights of others. These rules are intended to be general guidelines. UNC reserves the right to modify these at any time for the safety and effective administration of the event.

BELOW ARE THE RULES AND REGULATIONS GOVERNING TAILGATING FOR UNC FOOTBALL GAMES:

1. The reserved tailgating area will consist of three parking spots. You may reserve an area for one game or for the entire season.
2. Each group is required to have a designated person who will be the group liaison and will be on-site during tailgating. This person will be required to sign-up the group and accept the responsibility for their party's actions, while assisting the UNC staff with issues that may arise.
3. Only gas grills will be allowed in the tailgate lot. You must place something (plywood, metal pan, etc...) underneath your grill to catch the grease. Letting the grill drip onto the pavement will not be permitted. Dumping of any waste (including grease) is not allowed and may result in eviction from the site and from future tailgates.
4. Alcoholic beverages must be in plastic cups, kegs, and bottles are not allowed on the premises. The group will be held responsible for the serving of beverages to individuals of the appropriate age. It is important to remember serving alcoholic beverages to minors is against the law and violators are subject to prosecution.
5. Alcoholic beverages, as used in this permit application, shall mean 3.2% beer
6. No person under the age of 21 years shall possess or consume any alcoholic beverage at the event authorized by this permit.
7. No person under the age of 21 years shall serve or otherwise dispense any alcoholic beverage at the event authorized by this permit.
8. No sale of alcoholic beverages, sale of cups, cover charge or other fee may be charged for the event authorized by this permit unless the proper Special Event License has been obtained from the City of Greeley and/or the State of Colorado.
9. Food and non-alcoholic beverages must be served at the event authorized by this permit.
10. Alcoholic beverages may not be taken from designated tailgating space.
11. Selling of anything is prohibited!!! This policy will be strictly enforced and only UNC Athletics, or their designated representatives will be allowed to sell merchandise. Food and drinks must be brought by the groups for their own consumption.
12. Each group is required and responsible for cleaning up after their party. Failure to do so can result in charges to clean the area, being billed back to the liaison with the possibility of suspension from further tailgating privileges.
13. If no damages are incurred, \$25 (per game requested) will be charged to your credit card for the tailgating fee. If you wish to pay by cash or check, you may do so; however a valid credit card # must still be given. By signing this form, you authorize the University of Northern Colorado to charge your credit card for the reasons listed above. UNIVERSITY OF NORTHERN COLORADO REGULATIONS
